



# SCWTCA Rescue Transfer Agreement

SCWTCA, Inc. is a nation-wide non-profit organization recognized by the American Kennel Club to preserve and protect Soft Coated Wheaten Terriers. Occasionally a Wheaten may be unsuited to its current owners and a new permanent home is needed. SCWTCA Rescue agrees to provide daily care including: food, water, shelter and veterinary care as needed while placement is sought.

The present owners, undersigned, agree to transfer ownership of their Soft Coated Wheaten Terrier and to relinquish all rights, the AKC Registration certificate, veterinary and other health records, and any additional information concerning the Wheaten to SCWTCA Rescue.

It is understood that:

- 1) SCWTCA Rescue will own the Wheaten prior to placement.
- 2) The Wheaten will first be evaluated over several days in a foster home to determine suitable placement.
- 3) SCWTCA Rescue has full authority and intent to place the Wheaten in an appropriate permanent home without consent of the prior owner.
- 4) No guarantee can be made as to SCWTCA Rescue's ability to place the Wheaten, and in some cases, euthanasia is necessary. This decision is to be made by SCWTCA Rescue.
